

Case Study of Nirmala Begging Child



Name : JalagadugulaNirmala

Age :14 years

Father: Venkati

Mother : Ademma Area : Ashok Nagar Mandal/Dist. : Vizainagaram

On 17th June' 2016, from 10 am, all the staff of Child Line started rescue mission on the part of Anti Child Labour Day at some important parts of Vizainagaram. The mission covered the areas from local Kota Junction to 3 Lantarlu. We identified 8 numbers of children who are begging at the 3 Lantarlu near Masjid. We brought them to the Office of Child Line with the help of Two Town Police personnel.

At around 12 noon, bringing all the 8 children to the Office of Child Line was took place and information to 1098 CCC was registered. In the manner, we talked to them and gathered the information. Nirmala is one of them whose age is 14 years. Her mother's name is Ademma and her Father's name is Venkati. They belong to SC (Paaki). Her father left the family alone and then her mother started begging and steeredNirmala also for begging. Nirmala stopped her education with the 3rd class in her childhood itself.

In this manner, we rescued them both and counselling was given. When we asked them about the reasons for begging, the conditions of their house and circumstances to stop education, Nirmala started weeping and said the following:

Back ground of the Child

Her father married 8 women. Her mother is mentally disordered. She has one elder brother but he married at the age of 16 and left the home. Nirmala has given the information that her mother has an idea to arrange marriage for Nirmala. In the meantime, she started begging to avoid leisure time. We suggested her that in view of her family condition, staying outside is not at all safe. Though we suggested repeatedly, she was not in a position to listen us. Then, we narrated the existing conditions and gave counselling her. We presented her to CWC Committee and the committee gave orders to take her to Vizag Girls Home. Based on the orders, we have taken her to Vizag Girls Home at around 6pm and her admission was done accordingly. We, once again, have given counselling to Nirmala as well as her mother. Now she is in good condition. It is happy that we stopped child marriage and protected her. It is also happy since she is continuing her education





Case Study of Master Yashwant Child Lost and Found



Gorle Yaswanth is a 2.6 years age boy, he is the native of Pydibheemavaram village, Ranastaam Mandal of Srikakaulam district. His mother is Simhachalam, father is Alchanna. Mother is a daily labour, she is taking care of her family. Father is a drunker, and everyday demands for food and money with his wife.

In this circumstances Yashwant came to a marriage with his parents to Vizianagaram. In marriage celebrations his father taken Yaswanth to a bar shop and there he left him and gone from the place. Yaswant lonely stand there and started crying. There one person found the child and keep with him.

We received a phone call from Vizianagaram local, he informed that he has a 2.5 year age child is with him, immediately team reached there and taken the child. But the child is too young to tell anything about their parents and etc., the information has given in all news papers and shown in local citi cable news. As per CWC orders child restored in SAA home.

Through news paper the parents of Yaswanth reached to the CL Office with all their proofs. Yashwanth's mother Mrs Simhachalam said, that "Yashwanth's father did not informed to her that Yashwant is missing. She thought that her husband taken the chid to their village. But when she reached to the village then she found child is not there then she asked to Atchanna but he dint replied anything. When they found in news paper then immediately reached to the Vizianagaram CL office on 02.05.216.

On 2nd May, 2016 counseled both the parents about taking care of children, and produced before CWC. After verification of all the proofs Mr. A.E. Roberts PD, DWCDA and CWC team handed over the child to his parents.

Now, the child is happy with his parents

The phone call received on 28th May, 15 from Suvarnna, she informed the marriage is on 28th May at 12:56 am in Goddukommu village. The child is 14 years studying 9th class in ZPH School.

After receiving the information the team verified and confirmed the marriage and child age is 14 years then informed to the related departments and reached the venue, where the marriage is going on. With the help of Police and other departments collected all the age proof and verified the date.

The child DOB is on 20th August, 2000, based on date of birth counselled the parents of sides, child and their relatives and stopped the marriage. Parents have given undertaking to stop the marriage.

Counselled the child for continuation of further education.
